STAMP DUTY ACT, No. 43 OF 1982

REGULATIONS made by the Minister of Finance under Section 69 of the Stamp Duty Act, No. 43 of 1982, read with Section 2 of that Act.

Regulations

The regulations made by the Minister of Finance, under Section 69 of the Stamp Duty Act, No. 43 of 1982 and published in *Gazette Extraordinary* No. 224/3 of December 20, 1982, as last amended by regulations published in *Gazette Extraordinary* No. 1125/17 of 31st March, 2000 are hereby further amended with effect from the midnight of March 08th/09th 2001, in Part I of the Schedule thereto, by the deletion of item 7 (a) thereof and the substitution therefore, of the following items :—

"7(a) Bond, pledge, bill of sale or mortgage for any definite and certain sum of money affecting any property other than any aircraft registered under the Air Navigation Act, (Chapter 365) - not being an instrument specified in items 7 (aa) and 7 (ab)	
(i) where such bond, pledge, bill of sale or mortgage is for a sum of money not exceeding Rs. 100,000 for every Rs. 1,000 or part thereof	2 00
(ii) where such bond, pledge, bill of sale or mortgage is for a sum of money exceeding Rs. 100,000 on the first Rs. 100,000	200 00
on every Rs. 1,000 or part thereof in excess of Rs. 100,000	5 00
(aa) Mortgage for whatever sum of money executed in respect of any commercial leasing transaction where the lease agreement is duly stamped,	
for every Rs. 1,000 or part thereof	1 00

(ab) Mortgage for whatever sum of money for the construction of a house or for the purchase of a house or a site for the construction of a house and the mortgagee is a licensed Commercial Bank or a licensed Specialized Bank or the Employees Provident Fund or the Employees Trust Fund or a Registered Finance Company or other body incorporated by an Act of Parliament and engaged in the business of lending —
