The Motor Traffic (Construction of Vehicles) Regulations published in Ceylon Government *Gazette* No. 10360 of 27th February, 1952 and subsequently amended and published in Government *Gazette* No. 248 of June 03rd 1983 is hereby further amended by insertion of following sub section 2.(3) immediately after sub section 2.(2) of section 2 thereof.

2. (3) Every Motor Vehicle shall be manufactured and assembled or manufactured or assembled with brand new parts.

The Motor Vehicle Fees (First Registration) Regulations, No. 1 of 2003, published in *Gazette Extraordinary* No. 1319/13 of December 17, 2003 amended and published in *Gazette Extraordinary* No. 1421/34 of 02nd December 2005 are hereby further amended by the substitution for Paragraph (2) of regulation 2 hereof, of the following Paragraph.

- (b) Manufactured and assembled or manufactured or assembled, Locally using new parts and chassis under license of the principal vehicle manufacturer abroad by an industry registered either with the Ministry in-charge of Industries or with the Board of Investment established by the Board of Investment of Sri Lanka Law No. 4 of 1978.
