ACTING under the powers vested in it by Section 12(2) of the Consumer Affairs Authority Act, No. 09 of 2003, the Consumer Affairs Authority directs that no importer, manufacturer, distributor or trader shall import, manufacture, distribute or store or sell or display for sale, expose for sale or offer for sale, wholesale or retail LPG steel cylinders used for domestic purposes and its related accessories listed below, unless the said items conform with the corresponding Sri Lanka Standards given below :
