Regulations

The regulations published in *Gazette Extraordinary* No. 1734/ 12 of November 30, 2011 are hereby amended as follows :-

(1) by the repeal of regulation 6 thereof, and the substitution therefor of the following :-

"6. No person shall transport any live rock within Sri Lanka without a licence issued by the Director General of National Aquaculture Development Authority or his authorized officer";

(2) by the insertion immediately after regulation 6 of the following regulations :-

"6A. An application for a licence under regulation 6 shall be substantially in the form set out in schedule I hereto.
6 B. Any licence granted under regulation 6 shall :

(i) not be transferable ;

(ii) substantially be in the form set out in Schedule II hereto and be subject to the terms and conditions as are specified therein" ;

(3) by the repeal of schedule I thereof and the substitution therefor of the following :-
